A conflict of interest is any situation in which a governor's personal interests or loyalties to another person or organisation could be seen to prevent a decision being made in the best interests of the school.

**NB:** *It is the responsibility of individual governors/trustees/ associate members to inform the relevant person at the school/academy of any changes in their business or personal interests so this grid can be amended accordingly and then dated. If in doubt, declare!*
